



REGULATIONS

I. ORGANIZER

1. The organizer of the Silesia Half Marathon is:

Silesia Pro Active Foundation

KRS: 0000334726, District Court in Katowice - East in Katowice,
Division VIII of the National Court Register.

2. The race is organized in cooperation with WPKiW S.A., Stadion Śląski and
University of Silesia.

3. The race is organized under the patronage of:

- President of Polish Athletic Association
- Chairman of WPKiW S.A.
- Provost of University of Silesia

II. DATE AND PLACE

1. The race will be held on October The 2nd, 2011 in Chorzów.

2. Start: 11.00 on Jerzy Ziętek Promenade (WPKiW), near „Kapelusz” exhibition hall.
Competitors must report at the start no later than at 10.50.

3. Distance: 21.097 km.

4. The race will be organized on a 7km loop (covered three times).

6. The course passes the asphalt park avenues of WPKiW.

7. On the route checkpoints will be placed. Competitors shortening the route will be
disqualified.

8. Participants are required to complete the race no longer than in 3 hours. All runners
who do not reach the finish line at 14:00, will have to leave the route.

9. The route will be positioned with nutritional points at 7.5km and 14.5 km of the route.
Players may leave their own supplements / drinks.

III. PARTICIPATION

1. Only the people who are at least 18 years old until October the 2nd, 2011 may
participate in the Silesia Half Marathon.

Persons over 16 are allowed to enter the race provided that the statement of
permission for the participation of a child on the responsibility of the parent/legal guardian
has been signed by the parent/legal guardian in the race office.

2. All participants must be verified before the race in the Race Office. During the
verification participants must have an ID card or other document confirming their identity.
The condition for participation in the race will be signing a declaration to start in the
competition on their own responsibility (Legal basis: Regulation of the Minister of National
Education of 12/09/2001, Dz. U. Nr 101 poz. 1095)

3. The verification of the players and the issuing of starting numbers will be in the race office located near the start / finish, Chorzów, WPKiW, "Kapelusz" exhibition hall between 7.30 and 10.00 on the day of the race and between 15.00 and 17.00 on Saturday, October the 2nd.

4. Runners are obliged to adhere to IAAF and PZLA rules as well as present regulations.

5. Time measurement and establishing the order of runners will be made with the electronic system.

6. Within the framework of the Silesia Half Marathon the 7km street run will be held.

The Participants of this race are obliged to adhere to present regulations.

7. The organizer provides a cloakroom and a deposit.

IV. APPLICATIONS

1. Registrations will be accepted by filling in the application form on www site of the race or in the Race Office.

2. The amount of fee depends on the timing and form of payment. Amounts:

- 30 zł for payment till September the 10th, 2011 (the date on the payment on the organizer's bank account matters);

- 50 zł for payment between September the 11th and September the 29th, 2011;

- 70 zł for payment in cash at the Race Office.

3. Starting fee is not refundable as well as the possibility of assignment to another participant in the race. Those who want to receive a VAT invoice must send via the contact form full details for the invoice (including the names of the persons taking part in the race).

4. Paying a fee entitles to receive:

- Commemorative medal at the finish line of the half marathon

- Meal after the race

V. CLASSIFICATIONS

1. In the Silesia Half Marathon will be arranged individual classifications for men and women, the age groups classification and the team classification (top five runners from the club, regardless of gender, provided the identical names in the declaration of the club - the winning team will be decided by the shortest amount of times).

2. Competitors who complete the course of the 7km street race will be classified only in the classification of individual men and women.

VI. AWARDS

1. Detailed information about the awards for the winners will be published till 11 September 2011
2. The official results of the competitions will be posted within 3 days after the race on the website: www.silesiapolmaraton.pl

VII. FINANCING

1. The costs of the race organization are entirely covered by the Foundation Silesia Pro Active and supporting institutions.
2. Participants cover all their costs.

VIII. FINAL PROVISIONS

1. Written protests may be brought to the office of the race no later than at 14.00. Protest will be considered provided that a deposit of 100 PLN has been payed. In case of failure, the deposit is not refunded. Protests will be considered during the half-hour after its notification.
2. During the race all runners must have their start numbers attached to the front of a t-shirts. Under penalty of disqualification it is unacceptable to obscure a start number (in part or whole).
3. Race will be held regardless of weather conditions.
4. Organizer does not provide accomodation.
5. The interpretation of these regulations belongs to the Organizer.
6. The organizer is not liable for accidents occurring on the route running, due to the fault of participants.
7. In matters not covered in the regulations, final decisions are taken by the organizer..
